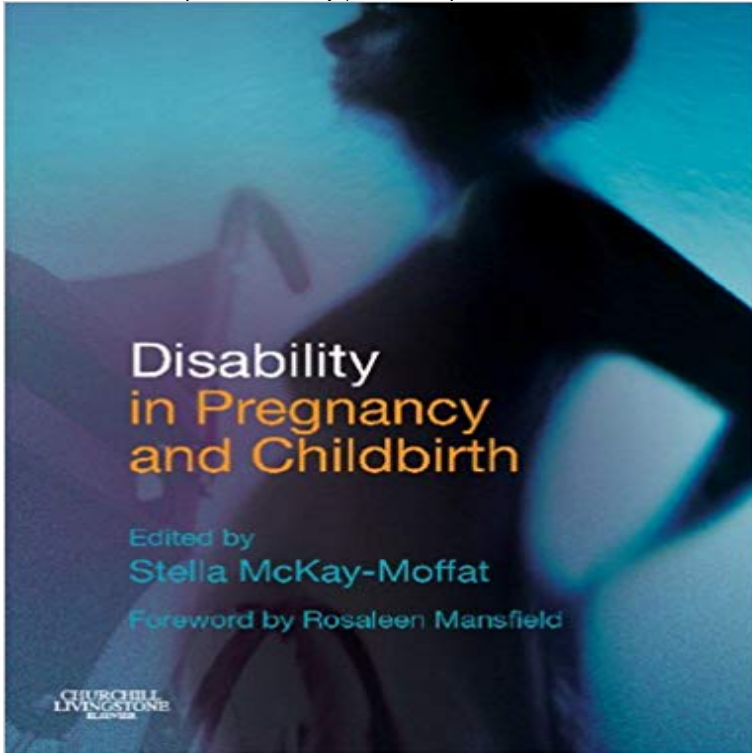


## Disability in Pregnancy and Childbirth
