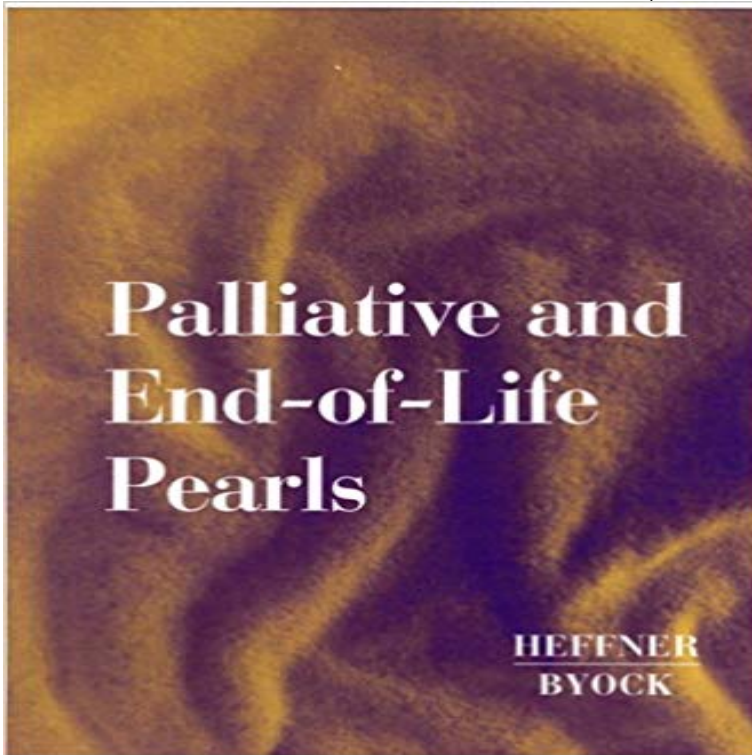


Palliative and End-of-Life Pearls, 1e
