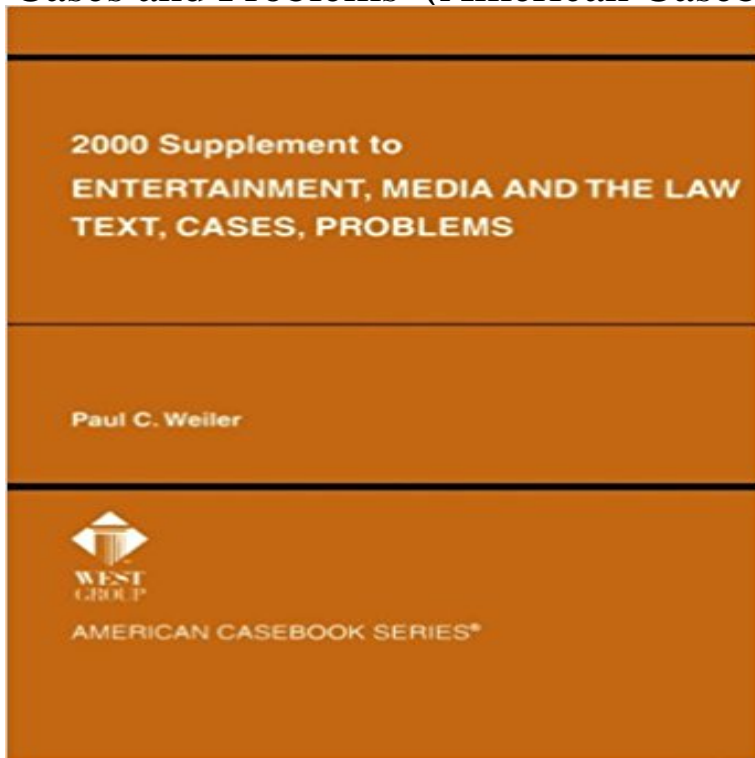


Weilers 2000 Supplement to Entertainment, Media, and the Law: Text, Cases and Problems (American Casebook Series®)
