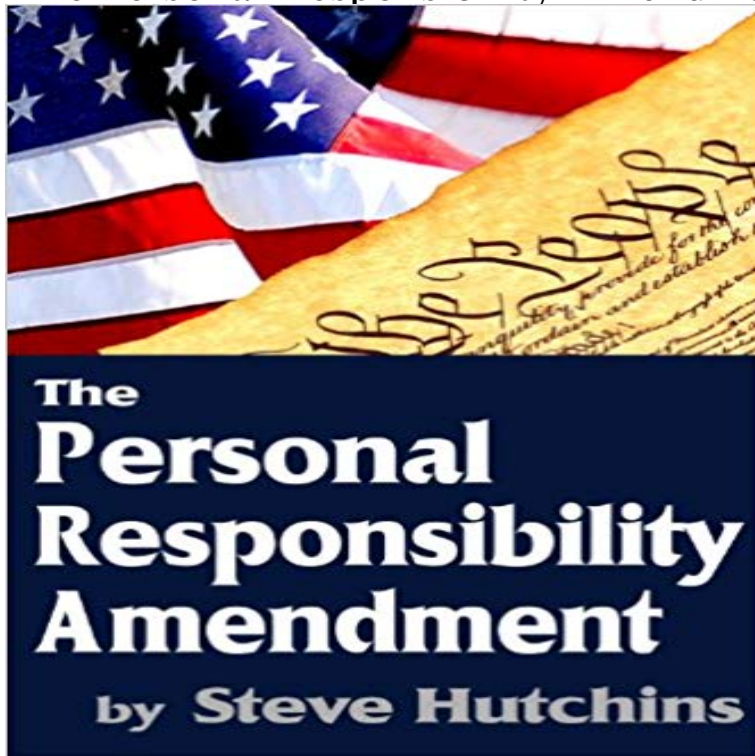


The Personal Responsibility Amendment
