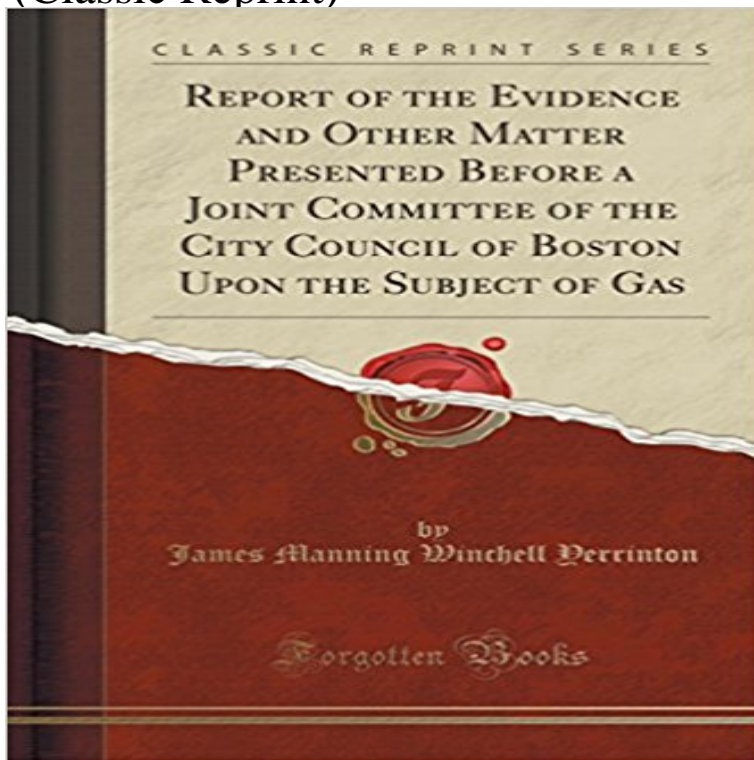

Excerpt from Report of the Evidence and Other Matter Presented Before a Joint Committee of the City Council of Boston Upon the Subject of Gas The present document owes its origin to the two following orders, offered by Alderman Nash, on the 2d of April, 1866: - Ordered, That the accompanying draught of a bill, entitled An Act for the regulation of Gas Companies, and the better protection of the Consumers of Gas in the city of Boston, be referred to a joint special committee, consisting of two on the part of the Board of Aldermen, and three on the part of the Common Council, with instructions to consider and report upon the expediency of its provisions, or what other legislative action may be expedient and desirable regarding the inspection of gas and gas-meters. Ordered That the Special Committee on the better inspection of gas and gas-meters consider also the expediency of the manufacture of gas by the city beyond or distant from the citys limits; and of the production and distribution of gas to the citizens at its minimum cost of manufacture. The special committee appointed were Messrs. Nash and Davies on the part of the Aldermen, and Messrs. Hyde, Stevens, and Hills on the part of the Council.
