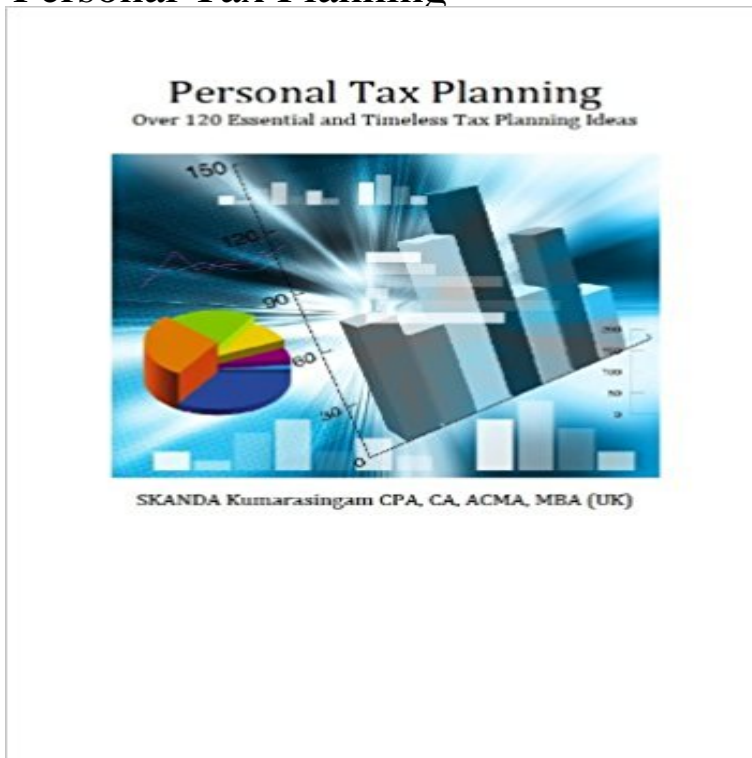


Personal Tax Planning
