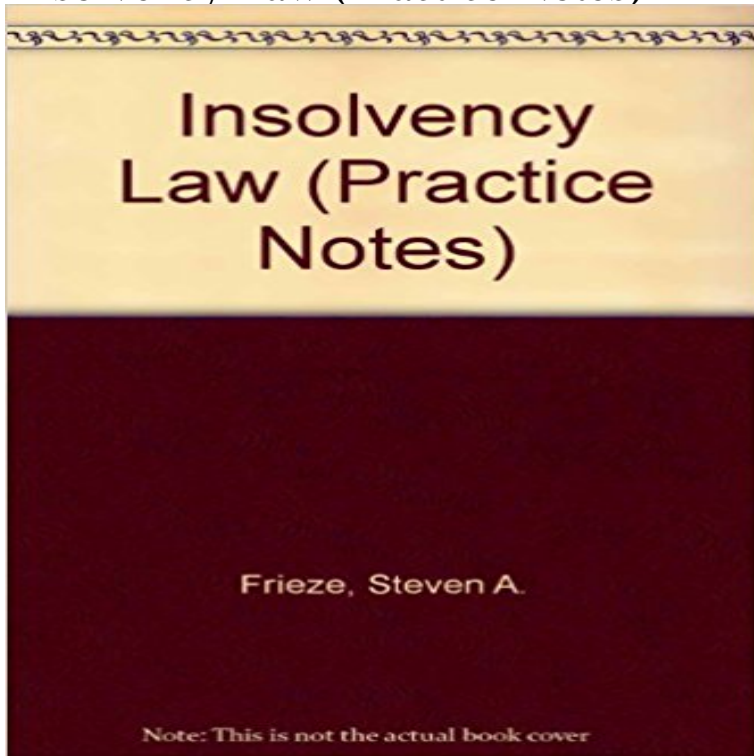


Insolvency Law (Practice Notes)
