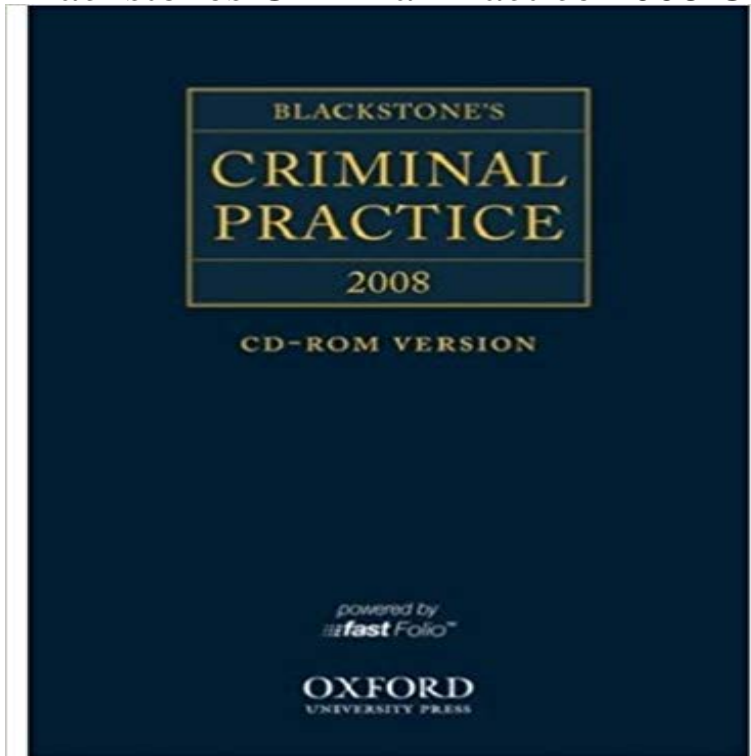


## Blackstones Criminal Practice 2008 CD-ROM
