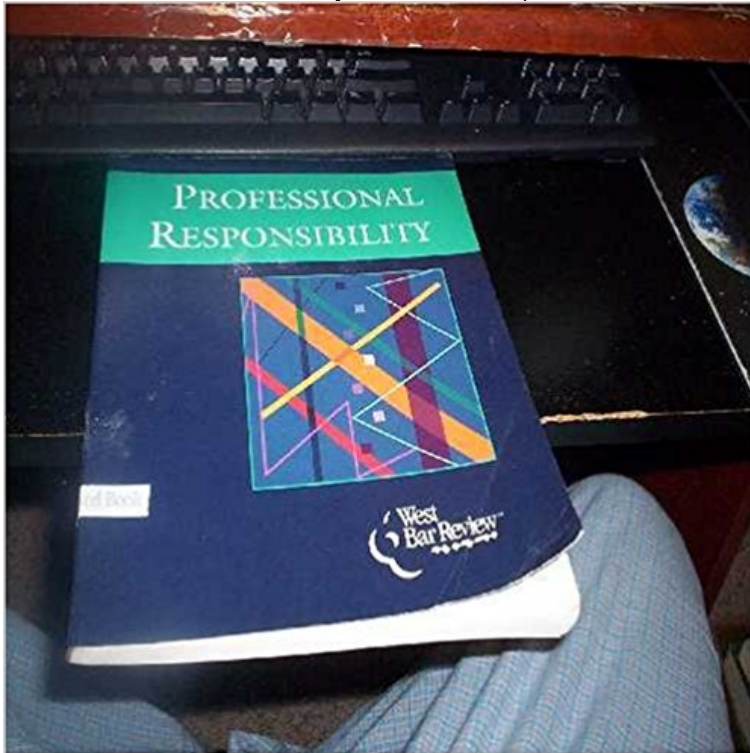


Professional Responsibility
