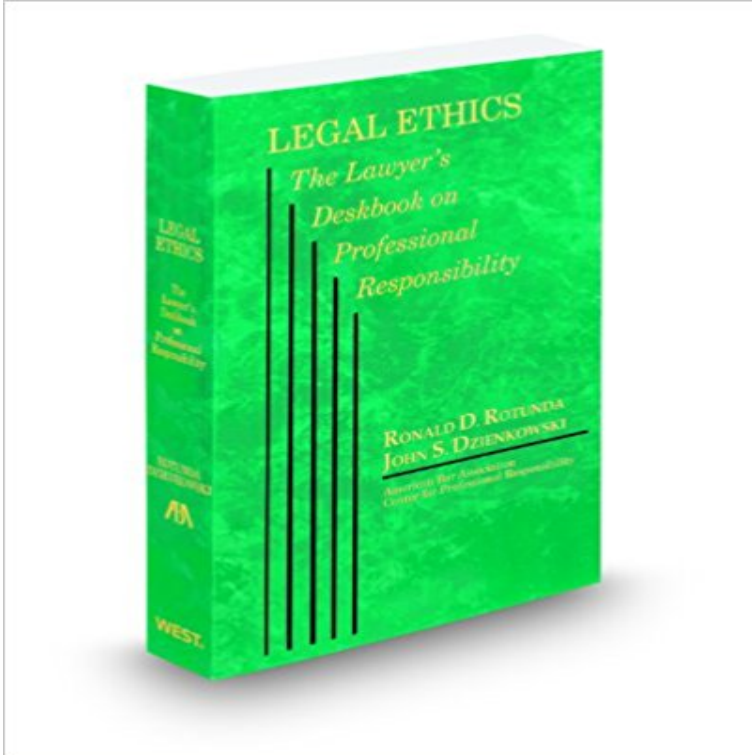


# Legal Ethics: The Lawyers Deskbook on Professional Responsibility, 2010-2011 ed. (ABA)
