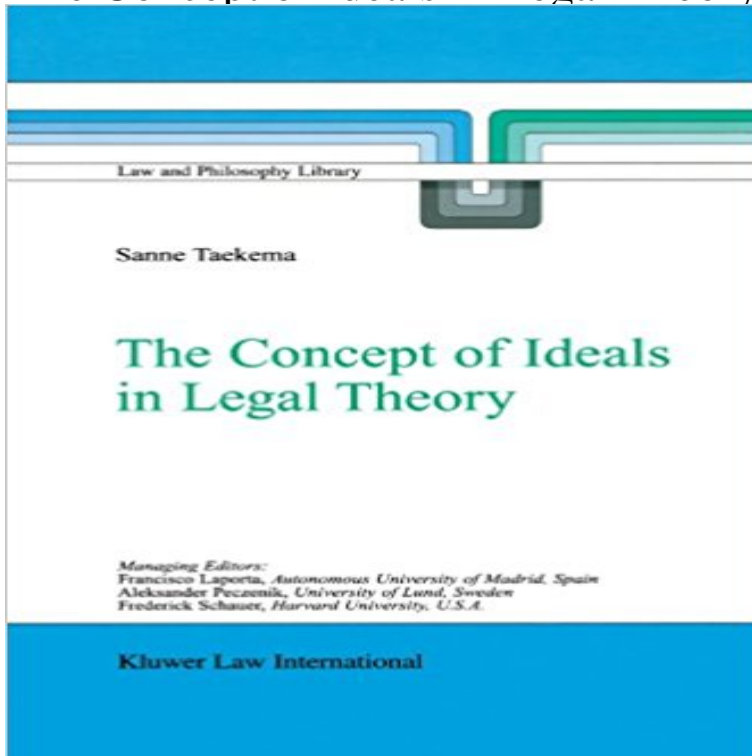


The Concept of Ideals in Legal Theory (Law and Philosophy Library)
