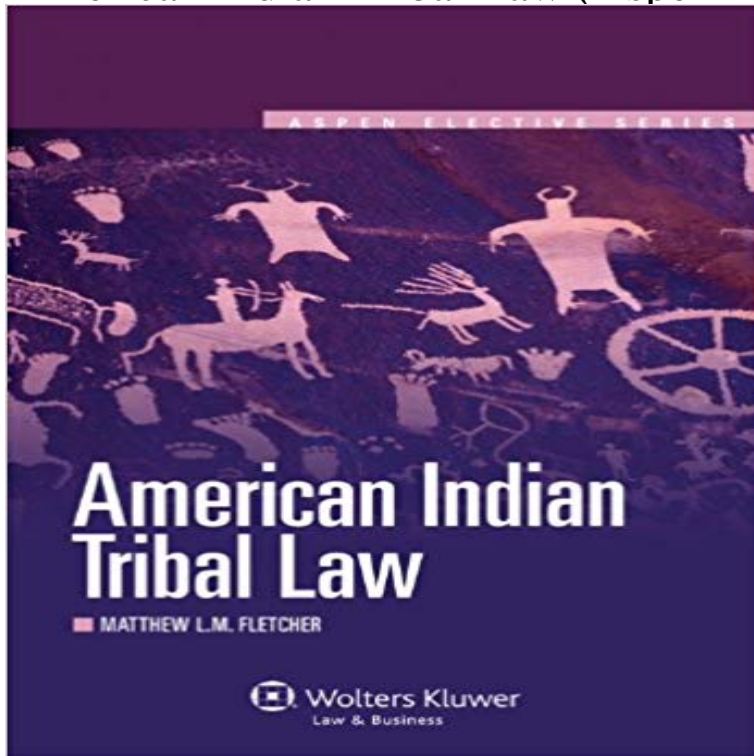


## American Indian Tribal Law (Aspen Elective)
