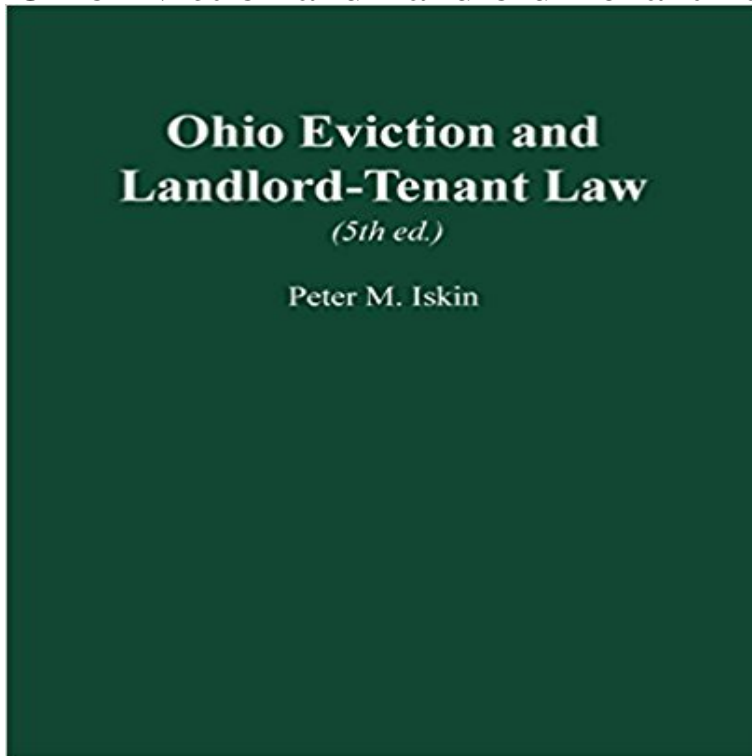


Ohio Eviction and Landlord-Tenant Law, 5th ed.
