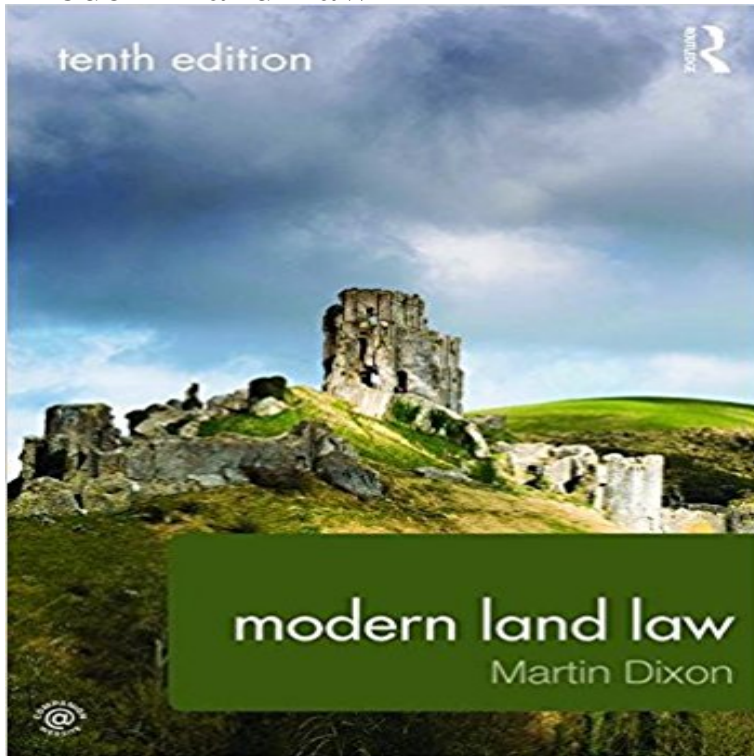


Modern Land Law
