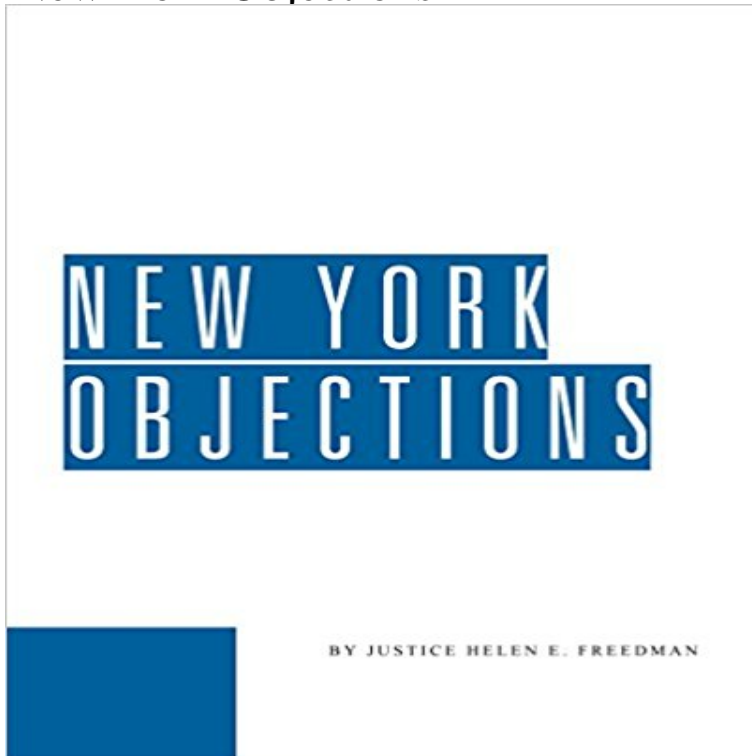


## New York Objections
