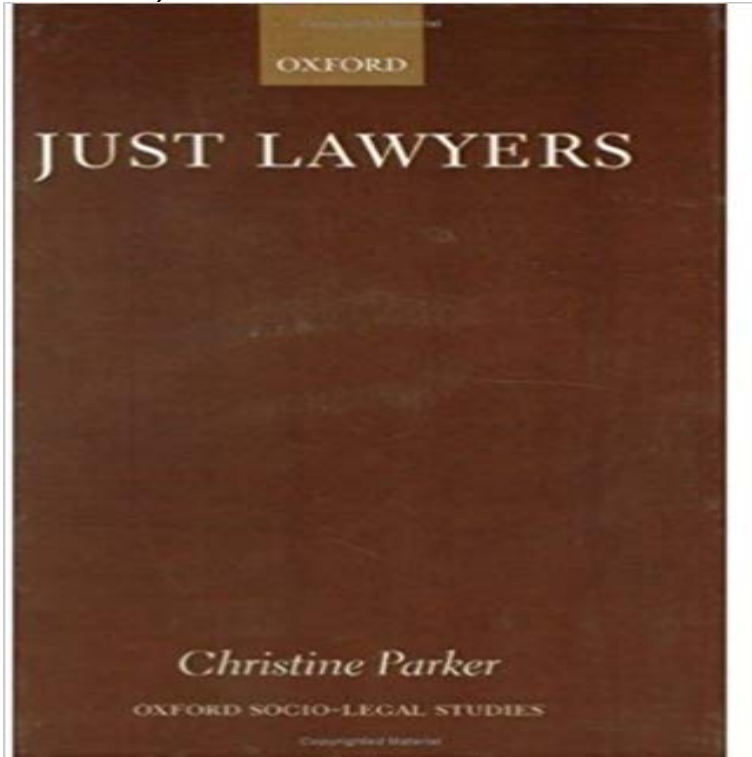


Just Lawyers: Regulation and Access to Justice (Oxford Socio-Legal Studies)
