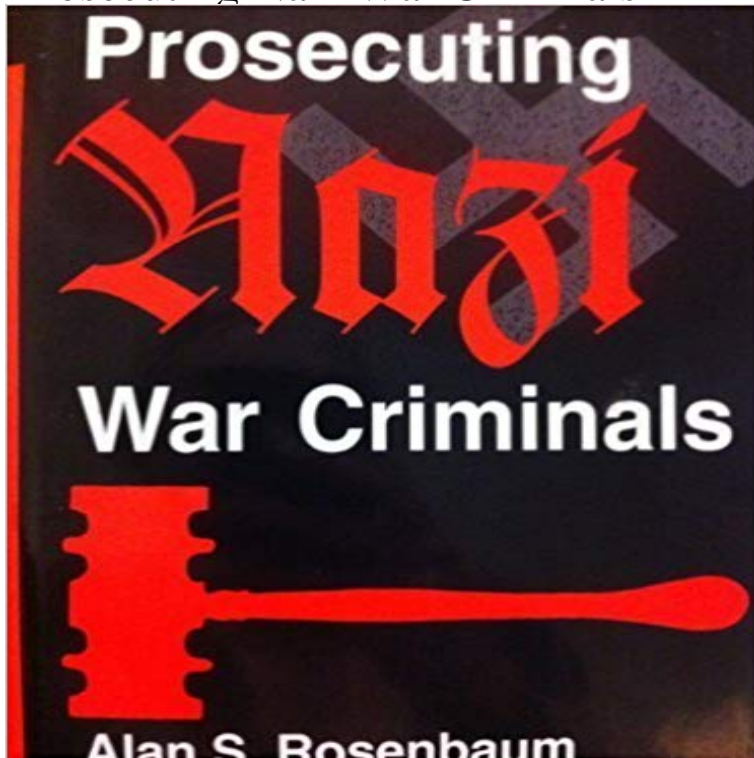


Prosecuting Nazi War Criminals
