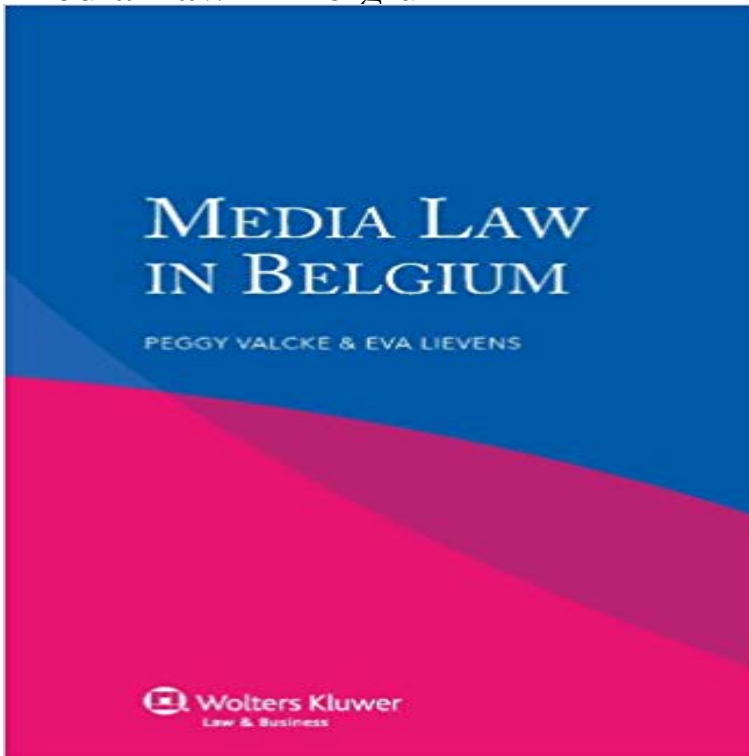


## Media Law in Belgium
