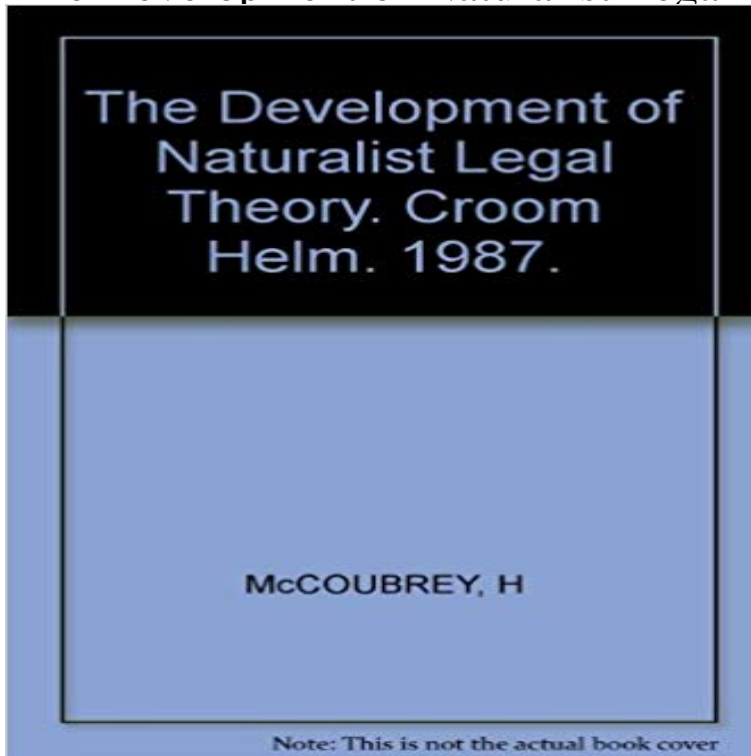


## The Development of Naturalist Legal Theory
