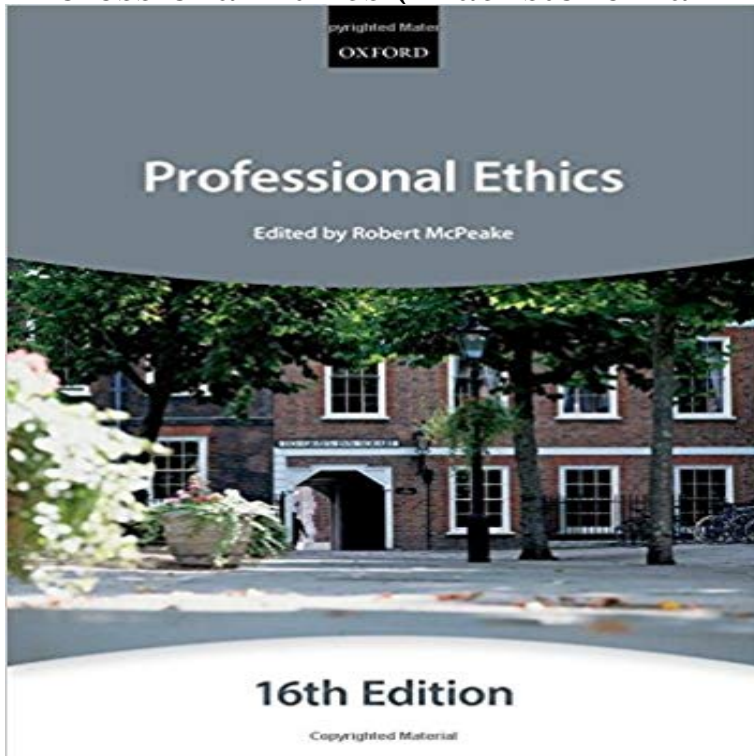


Professional Ethics (Blackstone Bar Manual)

The manual also features a dedicated chapter which identifies the key principles of professional conduct applicable to the core skills of the barrister ensuring that the reader is fully able to uphold the high professional standards of the Bar across all areas of practice. Potentially problematic areas of practice are identified throughout, and practical guidance is given on the correct approach to follow in such situations should they be encountered in practice. The manual also features a number of exercises designed to encourage the reader to consider how professional conduct principles apply to realistic scenarios. For ease of reference, the full Code of Conduct is provided as an appendix at the end of the manual. Professional Ethics is essential reading for all trainee barristers, and is a useful source of reference for practitioners seeking to refresh their knowledge of the rules and principles of professional conduct which govern practice at the Bar.
