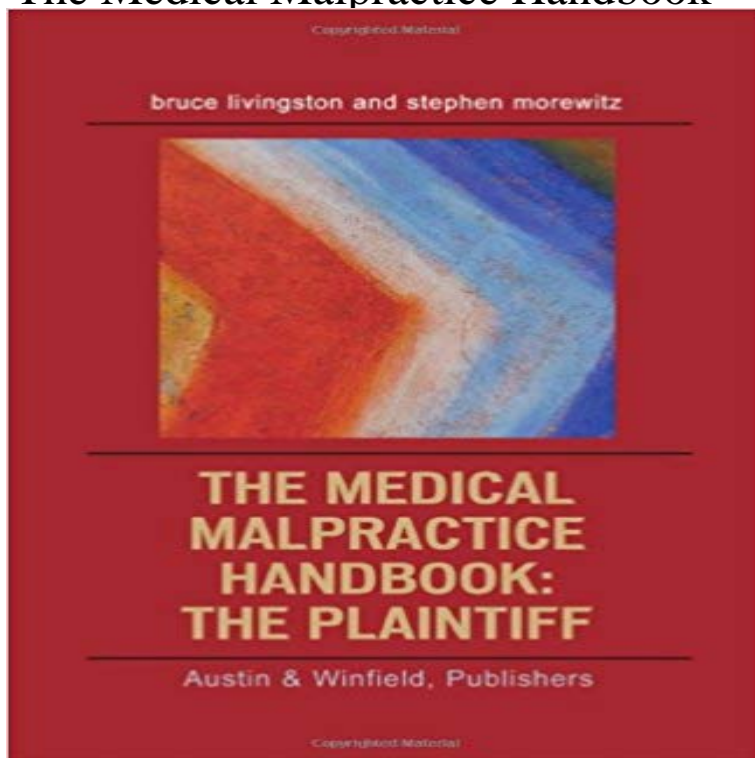


The Medical Malpractice Handbook
