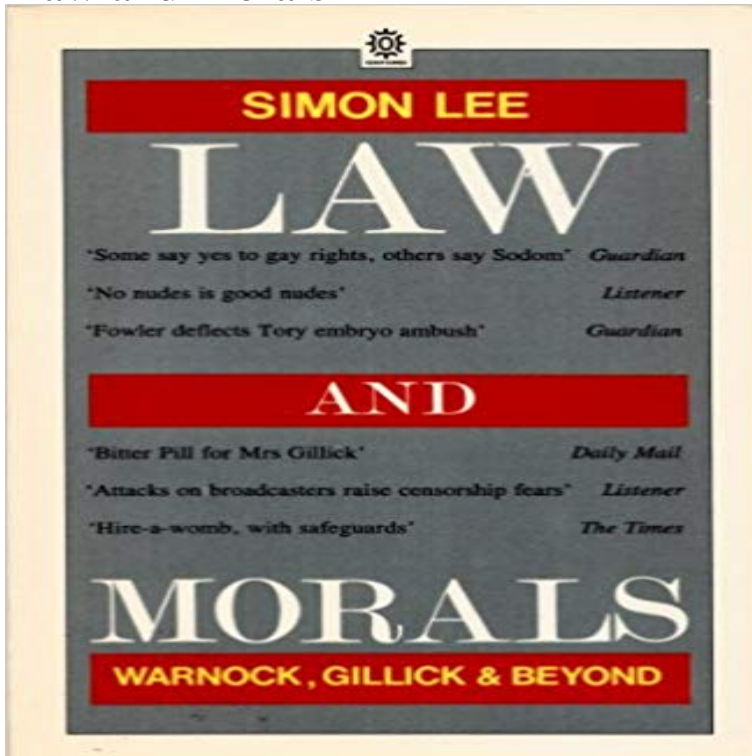


Law and Morals
