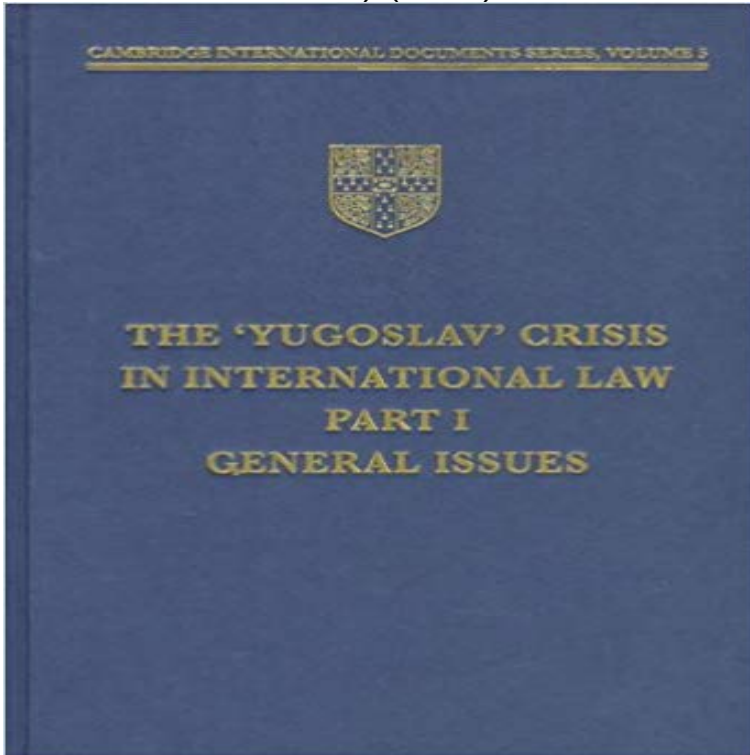


# The Yugoslav Crisis in International Law (Cambridge International Documents Series) (Pt.1)
